### PROF. DOUGLAS BOATENG

Professors Douglas Boateng (MSc, EngD, FCILT[1], FSOE, FIPlantE, FCIPS[2]FCMI[3], FIC[4], Finst.D[5] FIOM[6], FCIPS[7], FIoD, CDir), is an international chartered director, industrialist, business strategist, industrial and operations engineer, adjunct academic, and a seasoned social entrepreneur. He holds a Postgraduate Certificate and Diploma in Company Direction, a master's in industrial and manufacturing Logistics Systems and a Doctorate in Engineering.

He was Africa's first-ever appointed Professor Extraordinaire for supply chain management, governance, and Industrialisation. With extensive experience and expertise in corporate governance, Director development, strategy, supply chain management and procurement, value chain relationships and trade development, he has successfully held several multi-sectorial C-Suite and chairmanship positions in various industries and government sectors. Prof. Boateng is the nonexecutive chairman of Ghana's Mineral Income and Investment Fund (MIIF). Under his supervisory leadership, the fund has grown from Assets under Management (AUM) \$180m to over \$1 BILLION\* within 22 months. He is also the non-executive chairman of Labadi Beach Hotel, a state-owned 5-star hotel currently one of the most profitable and admired for service quality in the ECOWAS sub-region. Under his guidance, the hotel has

continuously declared record dividends to the state.

Prof Douglas Boateng has been inducted into various global institutional and organisational Walls of fame. Among them is the Institute of Directors Southern Africa (2008) for his worldwide contribution to logistics, supply chain governance and management. For various ground-breaking awareness campaigns, leadership roles, mentorships, public speaking and thought-provoking publications and books on supply chain management governance, strategic sourcing and its inextricable link to industrialisation and long-term economic development, he has also been honoured with over six (6) independent lifetime achiever's awards from various global organisations including Hewlett Packard(2018)

He is the Founder of PanAvest International, the founding non-executive chairman of MY-future YOUR-Future and OUR-Future ("MYO") and the originator and wordsmith for the highly popular daily NyansaKasa ("words of wisdom"), which has over a million global daily readers and followers aiming to inspire themselves and others for mindset change in support of the UNSDGS and long-term inclusive development. Other notable roles include an adjunct industrialisation and supply chain governance professor at the University of Mines and Technology (UMAT).

He is also an elected FELLOW of the Institute of Directors - UK & South Africa; Society of Operations Engineers - UK; Institution of Plant Engineers - UK; Chartered Institute of Logistics and Transport - UK & South Africa; Chartered Management Institute - UK; Chartered Institute of Procurement and Supply - UK; Institute of Business Consulting - UK; and the Institute of Operations Management - UK.

Prof Boateng has authored over 90 publications, including (1) Ground-breaking French and English manuscripts on (1a) Supply Chain Management, (1b) Strategic Sourcing and Industrialisation, (2) Pioneering, easy-to-digest and practical perspective books on (2a) Boardroom Dynamics and Governance, (2b) UNSDGs, and (2c) Negotiations.

## HON. DR. MOHAMMED AMIN ADAM

Hon. Dr. Mohammed Amin Adam, the Member of Parliament for the Karaga Constituency in the Republic of Ghana, was appointed as the Minister for Finance on February 14, 2023. His distinguished career spans various key positions, reflecting his deep expertise in finance, energy, and governance.

Prior to his appointment as Finance Minister,

Dr. Amin Adam served as Minister of State at the Ministry of Finance. He held the portfolio of Deputy Minister for Energy, overseeing Ghana's petroleum sector from 2017 to 2023. He also served as Deputy Regional Minister for the Northern Region in 2005 and later as the Mayor of Tamale in 2006.

With a strong background in extractive industries and resource management, Hon. Mohammed Amin Adam has played pivotal roles in shaping Ghana's energy landscape. He founded and served as the Executive Director of the Africa Centre for Energy Policy (ACEP) and held positions such as Energy Policy Analyst at the Ministry of Energy and Commissioner of the Ghana Public Utilities Regulatory Commission. His extensive experience also includes serving as the Africa Coordinator of extractive industries at IBIS. Dr. Amin Adam holds a Ph.D. in Petroleum Economics from the University of Dundee, specializing in petroleum fiscal policy and resource governance. He earned his MPhil in Economics and B.A. (Hons) in Economics from the University of Cape-Coast and a Master of Arts in Economic Policy Management from the University of Ghana-Legon. He attended the Northern School of Business from 1988 to 1991 and Tamale Secondary School from 1991 to 1993.

He is a fellow of the Institute of Certified Economists of Ghana (ICEG) and has undergone professional development training at esteemed institutions such as Columbia University, the University of Texas at Austin, and Harvard University.

Beyond his ministerial duties, Hon.
Mohammed Amin Adam chairs several
committees and initiatives in Ghana, including
the National Energy Transition Committee, the
Gold for Oil Initiative, and the New Producers
Group, demonstrating his commitment to
advancing Ghana's economic development
agenda.

A Fellow of the Institute of Directors-Ghana, she has served as Chair of three (3) Interim Management Committees (IMC) following nomination by Council to manage transitions.






#### PROF YAW ACHEAMPONG BOAFO ESQ

Yaw Acheampong Boafo educated at the University of London and the University of the West of England. He was called to the Bar of England and Wales at the Honourable Society of the Inner Temple on 28th July 1994 and enrolled on the Roll of Lawyers of the Republic of Ghana on 6th October, 1995. He is the current Head of Chambers and Managing Partner of the law firm S.K. Boafo & Co, which was founded by his father Hon. S.K. Boafo in 1978.

He served as the President of the Ashanti Region Branch of the Ghana Bar Association and a member of the General Legal Council from 2013 to 2016. He also served as a member of the Legal Service Board representing the Ghana Bar Association from February 2013 to January 2021. He served as the National Secretary of the Ghana Bar Association from September 2018 to October 2021.

He is the current National President of the Ghana Bar Association having been sworn into office on 1st November 2021. He is a member of the General Legal Council and the Judicial Council of the Republic of Ghana. He is the current Chairman of the Advisory Board of the Nurses and Midwives College, Kumasi. He is also a Commissioner of the Securities and Exchange Commission of the Republic of Ghana. He is also a member of the Governing Board of the Legal Aid Commission of the Republic of Ghana.
